Marian University meets the assurances above by requiring all education students to participate in modules on urban education. Our alternate route program prepares students for teaching in low income and urban areas and/or with English language learners. Marian University requires all candidates to take courses which focus on teaching English learners, teaching students with Exceptional Needs, and multicultural education. Teacher preparation programs assess candidate proficiency in teaching K-12 students who represent all types of diversity, including ages and developmental levels, special learning needs, races, cultures, languages, religions, personal attributes, and socio-economic status. All candidates must exhibit proficiency in developing curriculum, lesson plans, instructional strategies, and assessment protocols relevant to teaching in diverse classrooms and promoting multicultural education. Candidates examine books and other materials for diversity infusion and curriculum transformation in preparation for teaching

competencies in diverse settings. Candidates must establish positive classroom climates and develop and deliver lesson plans which incorporate diversity and promote social justice.

In order to prepare teachers to teach 21st century students with 21st century technologies, The Fred S. Klipsch Educators College at Marian University provides a robust and well rounded approach to preparing teachers. Not only is emphasis placed on teaching pre-service teachers how to utilize software applications for publishing, presenting, collaborating and communicating; research-based approaches are modeled and taught on how to best utilize technology to differentiate instruction for students with diverse learning needs and modalities. A variety of digital tools and platforms are demonstrated and taught so that teachers remain current with regard to selecting and using digital tools best suited for the subject and grade level they will teach. Additionally, interactive white boards, iPads and mobile devices provide opportunities for teachers to further engage students in the classroom. Teachers demonstrate their ability to plan for instruction and assessment using digital tools and applications. Integral to our approach in choosing and using educational technology is the idea that software and digital tools are not the focus of student learning, but rather a means to expedite, enhance and engender the learning and assessment experience in their future classrooms. As blended learning and flipping the classroom gain momentum and optimize the learning experience in both face-to-face, virtual and hybrid learning environments, a concerted effort has been made to integrate these tools more fully, and leverage their benefits throughout the campus. Capturing data and making data-informed decisions enable instructors and teaching candidates at Marian University to organize, report and understand data from both a micro and macro view. MUHUB (our student information system), Canvas (our LMS), Airtable (our data management system) and various other cloud based applications facilitate the collection, analysis and reporting of data that help measure and communicate progress on student learning outcomes. Together these data collecting technology tools provide a means whereby students can quickly and more efficiently have access to grades and feedback via formative and summative

assessments. Finally, online surveys (Qualtrics) provide “just in time data” so that course design decisions can be made quickly for the next week, month or semester.

Teacher Training

1. Provide a description of the activities that prepare general education teachers to:

a. Teach students with disabilities effectively

All teacher candidates take EDU523/525- Teaching Students with Exceptional Needs. There is an emphasis on the legal aspects of educating and supporting students with exceptional needs and how this transpires in a classroom. Teacher candidates learn about all thirteen eligibility categories and how to design, adapt, provide instruction and support students with exceptionalities in their classrooms. We also teach identification and best practices for trauma informed students and those students who are victims of toxic stress. Candidates learn about evidence-based strategies and practice, and the implementation of these strategies with intervention plans when they identify a missing or lagging skill that a student has. General Education candidates learn specific collaborative strategies with special education teachers and related services to assist educating students with exceptionalities. General education candidates learn the different co-teaching strategies, apply these multiple strategies and incorporate special education teachers as co-partners in the classrooms. Candidates learn about family collaboration and how to connect with different members of their school and community to strengthen their teaching. They learn effective skills to collaborate respectfully and as a team member, providing support and encouragement to build trust and effective programming. Throughout the program, there is an emphasis on lesson planning where students must consider the unique needs of all students, specifically planning for the accommodations required for students with disabilities and ongoing collaboration with special education staff in their schools.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

All teacher candidates cover their roles/responsibilities in the IEP process in their EDU523/525 course. Candidates will evaluate and interpret first the psychometric reports and the indicators that support both the strengths and missing and lagging skills of an individual student. This provides them with the initial tools to collaborate and support parents and other members as fellow team members on an IEP team and provide insight into accommodations based on missing and lagging skills. Candidates confidentially review multiple IEPs of their students in class and identify the strengths and weaknesses as to how these are written. Writing measurable goals is something candidates study and practice in their first year then apply to an IEP meeting. The collaboration course helps candidates to problem solve, resolve conflict, and collaborate with a shared vision of student success with students as well as the different team members of the IEP meeting.

c. Effectively teach students who are limited English proficient.

All candidates take EDU516 - Family and Teacher Interaction in Diverse and Inclusive Settings and EDU-514 Second Language Learning.

a. Teach students with disabilities effectively

For candidates in degree seeking programs, there are courses that detail effective strategies for teaching students with disabilities. SPD 535 Introduction to Exceptional Needs provides a foundational understanding of what exceptionality is and how it presents in a school environment. Candidates learn about the importance of individualizing learning for each child and begin learning about different disabilities and some strategies on how best to serve them. In SPD 533 Assessment of Children with Exceptional Needs candidates learn all about psychoeducational evaluations and the information they provide as it pertains to teaching students with disabilities. Candidates also learn about how to provide accommodations and individualized supports to best assess children with disabilities. In SPD 538 Methods and Management, candidates go even deeper on specific strategies to work with students. Many of the candidates are working in schools already and they get to incorporate their own experiences into the learning and share with their classmates. For candidates in our non-degree program (SPED Prep), the content is very similar but presented in a module format. There is a high degree of emphasis on teaching literacy skills through the use of the Orton-Gillingham method. The candidates in this program all work in a school to complete the internship part of their program, where they are observed at least four times and given feedback specific to serving the students with disabilities in their classroom.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

Candidates in degree-seeking programs take SPD 549 Exceptional Needs: Collaborative Consultation, where part of the course is focused on the different roles of the IEP team and how to effectively collaborate with colleagues and families in this context. Candidates will share their experiences as many are working in schools already and actively doing this work. While protecting the confidentiality of their students, the classes will engage in discussion on what they are experiencing and learning for the benefit of the class. For candidates in our non-degree program (SPED Prep), the internship requires candidates to participate in and reflect on being part of an IEP team, to create a comprehensive plan for the students they are serving to participate in state testing, and to conduct a Functional Behavior Analysis (FBA) and write a Behavioral Intervention Plan (BIP) for a student exhibiting problem behavior. In addition to this, there is content in the modules that gives a great deal of legal context to special education, IEPs and the special education teacher's role in serving students with disabilities as it pertains to collaboration within the school and with the family.

c. Effectively teach students who are limited English proficient.

All teacher candidates in the Klipsch Educators College are prepared to teach limited English proficient students. Candidates in all degree seeking programs are required to take a course which is focused on language acquisition, teaching students at various levels of language acquisition, and the effects of culture and acculturation on academic achievement. The courses which are specifically designed to teach this content are EDU 518 English Learners in Diverse & Inclusive Classrooms and EDU 514 Second Language Learning. Candidates in non-degree programs are prepared to teach limited English proficient students. Candidates learn about language acquisition, teaching students at various levels of language acquisition, and the effects of culture and acculturation on academic achievement. This content is within the module-based learning focused on how to accommodate for individual students' needs, strategies for providing multiple models of representation, and the Orton-Gillingham model for teaching literacy skills.
