## 2019-20 Identity/Statement of Educational Purpose Worksheet

Your 2019-20 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. To verify that you provided correct information, we will compare your FAFSA with the information on this institutional verification document and with any other required documents. If there are differences, your FAFSA information may need to be corrected. You and a parent whose information was reported on the FAFSA (if applicable) must complete and sign this institutional verification document, attach any required documents, and submit the form and other required documents to us. We may ask for additional information. If you have questions about verification, contact us as soon as possible so that your financial aid will not be delayed.

### Instructions:

**The student must appear in person at Marian University to verify his or her identity by presenting a valid government-issued photo identification (ID). Examples of accepted forms of ID are listed in section B below. The institution will maintain a copy of the student's photo ID that is annotated with the date it was received and the name of the official at the institution authorized to collect the student's ID.**

**In addition, the student must sign, in the presence of a Marian Financial Aid Officer, the statement in section C.**

**If the student cannot appear in person, the student must send us a readable photocopy of the acceptable Photo ID, and the student must sign, in the presence of a notary, the statement in section C.**
