Major for Bachelor of Science (B.S.) in Applied Physics: 60 credits in the sciences requiring an applied physics core of PHY 201, 202, 212, 220, 440, 2 hours of 460 or 498, and 490, and 2 of the following: CHE-325, PHY 330, or 350. Mathematics requirements are MAT 230 and 231. The remaining courses are chosen from EGR 200 and above, CST 200 and above, MAT 305 and above, and CHE 300 or 425.

Example 2:

New major in MA in Leadership Practice:

EFFECTIVE: Fall 2022

Master of Arts in Leadership Practice: a minimum of 30 credits including TLL 610, 616, 618, 640, 643, 647, 649, 697, and LDR 628, 638, 648, and 698.

New minor in Creative Writing:

Minor in Creative Writing: 18 credits including ENG 109, 113, 204, 302, 309, 370, 401, 470.

Example 1:

Change requirements for business analytics major:

FROM: Major for Bachelor of Science Degree (B.S.) in Business Analytics: 61 credits including: 42 credit business core; AIM 223, 323, 423; CST 150 or 171; MGT 330; one course from AIM 320, CST 200, MAT 322, MGT 350, MKT 344. The core requirement for elective business experience should be satisfied with an internship in business analytics.

TO: Major for Bachelor of Science Degree (B.S.) in Business Analytics: 61 credits including: 42 credit business core; AIM 223, 323, 423; CST 150; MGT 330; one course from AIM 320, CST 171, MAT 322, MGT 350, MKT 344, 374. The core requirement for elective business experience should be satisfied with an internship in business analytics.

Example 2:

Change requirements for history minor:

FROM: Minor: 18 credits, including 102.

TO: Minor: 18 credits, including 100 or 101; 200, 216 or 217; remaining 12 credits selected from HIS courses.

Example 3:

FROM: Major for Doctor of Education Degree (Ed.D.) in Organizational Leadership: 57 credits including core requirements LDR 701, 710, 715, 717, 730, 740, 781, 783, 785, 787, 790, 793, 795 and one concentration from:

Concentration in Organizational Leadership: LDR 720, 743, 750, 753, 761, 762, 770

Concentration in Superintendent Licensure: LDR 750, TLL 722, 732, 742, 752, 760, 762, and 860.

TO: Major for Doctor of Education Degree (Ed.D.) in Organizational Leadership: 57 credits including core requirements LDR 701, 710, 715, 717, 740, 750, 781, 783, 785, 787, 790, 793, 795 and one concentration from:

Concentration in Organizational Leadership: LDR 720, 730, 743, 753, 761, 762, 770

Concentration in Superintendent Licensure: LDR 730, TLL 722, 732, 742, 752, 760, 762, and 860.

III. Delete current program proposal:
